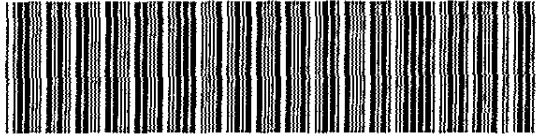

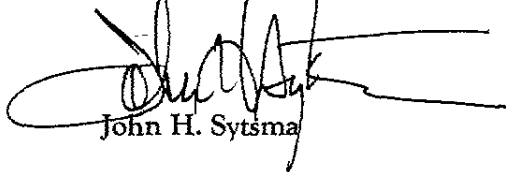

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is ROBERT SIPRELL FINISH CARPENTRY, INC. and its principal place of business shall be located at 178 Avenue C, Apalachicola, Florida 32320.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One (1) share of common stock at One Dollar (\$1.00) par value, which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

ARTICLE VII - DIRECTORS

Initially, this corporation shall have One (1) Director who shall serve until their

ARTICLE X - INDEMNIFICATION

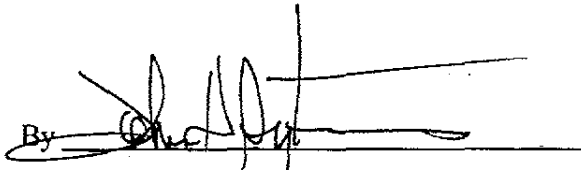

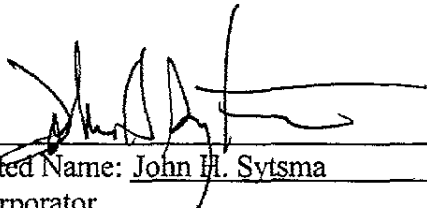

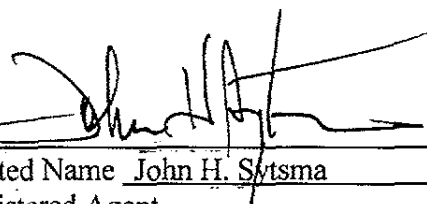
