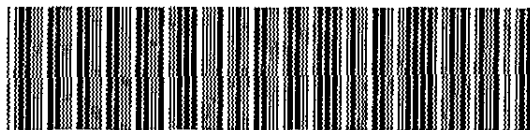

ARTICLE I - NAME

The name of this Corporation shall be:
PakMail of Tampa, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on September 22, 2003.

ARTICLE III - PURPOSE


