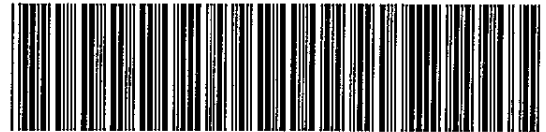

The undersigned's purpose is to form a professional corporation under the Florida Corporation Act and does hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation is Scorpion Management Incorporated.

**ARTICLE II - PRINCIPAL OFFICE**

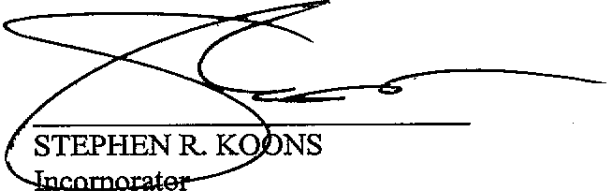
#### ARTICLE XI - AMENDMENT
