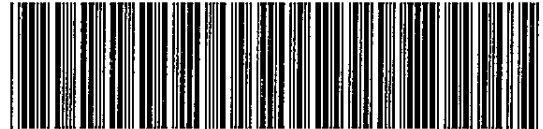



OF
ICHETUCKNEE FOREST, INC.**

A Florida Corporation

The undersigned, acting as Incorporator of a corporation pursuant to Chapter 607, F. S., adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of this corporation is **ICHETUCKNEE FOREST, INC.**

ARTICLE II

Principal Office

The corporation's principal office address is 412 N.E. 16th Avenue, Gainesville, Florida, 32601. The mailing address is the same, as is the registered office address.

ARTICLE III

Purpose




