



These Articles of Incorporation are signed by the incorporator for the purpose of forming a profit corporation pursuant to Chapter 607 of Florida Statutes as follows:

**ARTICLE I**

The name of the corporation is A-GOOD COMPUTER SERVICE, INC. For convenience, the corporation will be referred to in this instrument as "the corporation".

**ARTICLE II**


