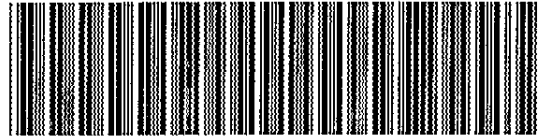

NAME OF CORPORATION

The name of this Corporation shall be:

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

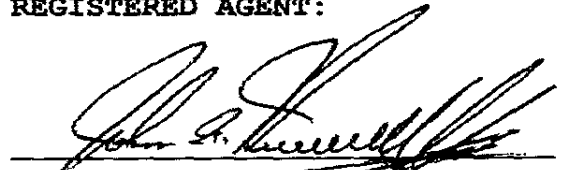
