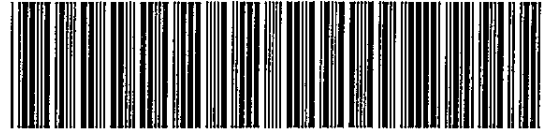

ARTICLE I

The name of this corporation shall be known as **PADILLA CARPENTRY CONTRACTORS INC.**, and the initial address of the corporation is 2375 Dora Dr. Lot D, Pensacola FL 32514 and the name of the registered agent is **Cereza D. Rockwell**, of 9015 Bowman Ave, Pensacola, FL 32534.

ARTICLE II

The period of the duration for this corporation is perpetual, unless dissolved according to law. The corporate existence shall commence on the 25th day of September, 2003.


