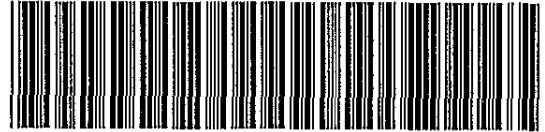

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is E & G DRYWALL FINISHERS INC.




