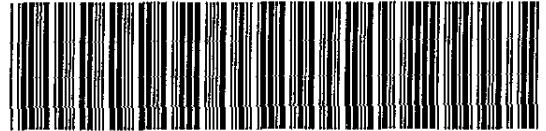

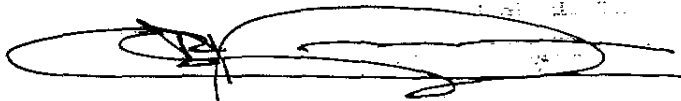

ARTICLES OF INCORPORATION

of

EDUARDO R. LAZARO, D.M.D., P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Professional Association under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the corporation is Eduardo R. Lazaro, D.M.D., P.A.

ARTICLE II - DURATION

The corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of engaging in the practice of Licensed Dentistry and any corresponding activities or business permitted under the laws of the United States and the State of Florida to further the practice of Licensed Dentistry.

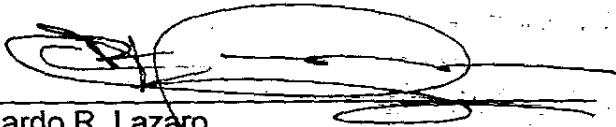

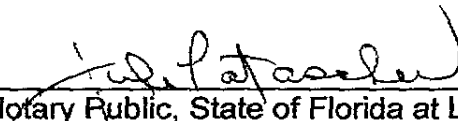

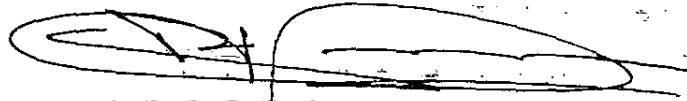
