## ARTICLES OF INCORPORATION

OF

## D.E.Y. INDUSTRIES, INC.

The undersigned, incorporator, for the purpose of forming a corporation under the Fibrida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

# ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is D.E.Y. INDUSTRIES, INC. herein after referred to as the "Corporation".

#### ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

### ARTICLE VI: PREEMPTIVE RIGHTS
