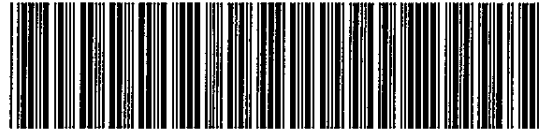


#### **ARTICLE VIII - INDEMNIFICATION**


