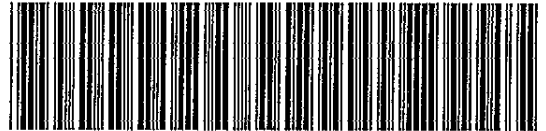

The undersigned, who is duly licensed to practice real estate in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopt the following Articles of Incorporation;

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II REGISTERED OFFICE AND AGENT

The location and address of the Corporation's initial registered office in Florida is 3462 Indian River Street, Spring Hill, Florida 34609. The initial registered agent at the registered office is Michael Peranio who upon accepting this designation agrees to comply with the provisions of Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process. The principal office of this corporation is 3462 Indian River Street, Spring Hill, Florida 34609

ARTICLE III PURPOSE

The purpose for which the Corporation is organized shall be to engage in the practice of real estate within the State of Florida, and to take all actions that are necessary or proper in connection with that practice.

No shareholder, notwithstanding that he or she may have voted against the amendment or may have objected in writing, shall be entitled to payment of the fair cash value of his or her shares or any other rights of a dissenting shareholder.
