



ARTICLE ONE

The name of the corporation is **INFANTE AND ASSOCIATES, INC.** The principal address of the corporation is: 3414 SW 107TH CT., MIAMI, FLORIDA 33165.

The period of its duration is perpetual.

ARTICLE FOUR


The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**


