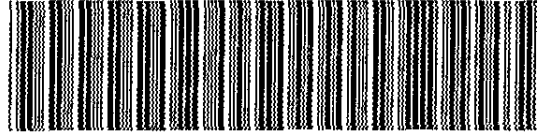

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation is C.Y. COMPUTERS, INC.

ARTICLE II

The existence of the corporation shall begin on the date of the filing of these articles of incorporation.

ARTICLE III

The street address of the principal office of the corporation is 7220 S.W. 16 Terrace, Miami, FL 33155.
