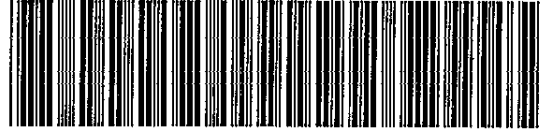



I, the undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be CGA & C ENTERPRISES, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is operation of a restaurant and any other commercial activity and any other activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE III - STOCK

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time is 100 shares of common stock at \$1.00 par value.

ARTICLE IV - TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V - PRINCIPAL PLACE OF BUSINESS

The initial street address of the principal office of this corporation is 1510 - 14th St. N., St. Petersburg FL 33704. The Board of Directors may, from time to time, move the principal office to any other address in Florida.

ARTICLE VI - DIRECTORS
