## ARTICLES OF INCORPORATION FOR PROFESSIONAL CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

### ARTICLE ONE Name

- 1.1 The name of the Corporation is The Koch Sisco Group, Inc.

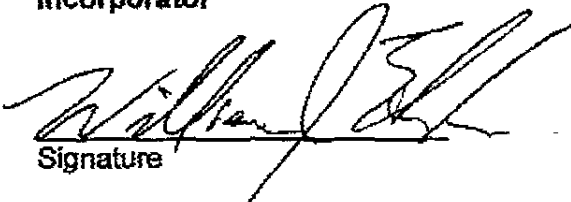
**ARTICLE SEVEN**
