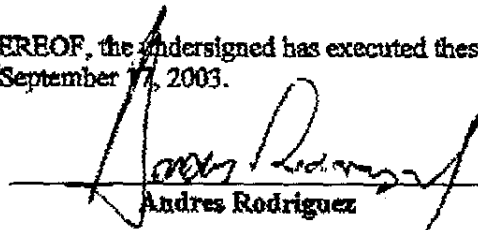
ARTICLES X - INCORPORATOR
