ARTICLES OF INCORPORATION OF COMFORT MEDICAL AIDS, INC.

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is COMFORT MEDICAL AIDS, INC., and the principal address and principal place of business is 7569 STARKEY ROAD, SEMINOLE, FLORIDA 33777

ARTICLE II - REGISTERED OFFICE AND AGENT
