ARTICLES OF INCORPORATION

OF

FIDELITY MUTUAL MORTGAGE, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 and/or Chapter 621, F.S. of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: FIDELITY MUTUAL MORTGAGE, INC.

ARTICLE II - PRINCIPAL OFFICE
