

ARTICLES OF INCORPORATION  
OF

ARTICLE I

The name of this Corporation is: Michael A. Sills, D.C., PA

ARTICLE II

This Corporation is organized for the purpose of transacting business as a professional, licensed chiropractor's office and all lawful business for which licensed physicians are permitted to conduct under Chapter 607 of the Florida Statutes.

ARTICLE III

This Corporation is authorized to issue 1,000 shares of common stock, no par value.

ARTICLE IV

The amount of capital with which this Corporation will begin business shall not be less than \$500.00

ARTICLE V

The Corporation shall have a perpetual existence.

director of this Corporation is hereby relieved from any liability that might otherwise exist from thus contracting with this Corporation for the benefit of himself or any firm, association or corporation in which he may be anyway interested. Any director of this Corporation may vote upon any contract or other transaction between this Corporation and any firm, association or corporation in which he may be anyway interested.




