**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be TOBY-DAVE, INC., with its principal place of business at 18860 U.S. Highway 19 North, Suite 127, Clearwater, Florida 33764.

ARTICLE II - NATURE OF BUSINESS

ARTICLE VI - BOARD OF DIRECTORS

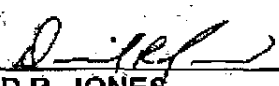

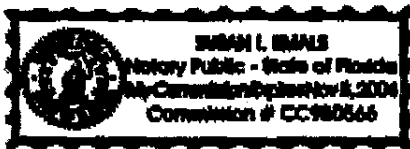
