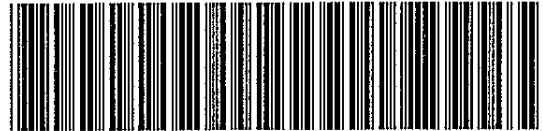

Articles of Incorporation

Article One: Name

The name of this corporation is Directors Home Inspection, Inc.

Article Two: Purposes

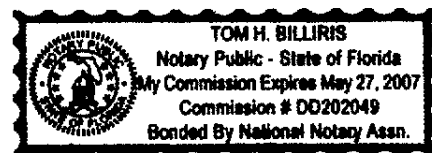
