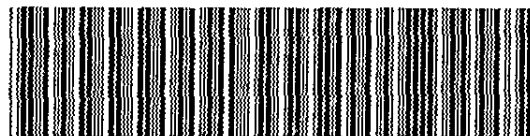

ARTICLES OF INCORPORATION
OF

I. NAME

The name of the corporation is Tara-Tek International, Inc.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.

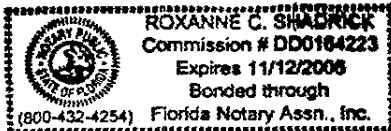
stockholders and all the directors sign a written statement manifesting their intentions that a certain amendment of these Articles of Incorporation be made.


