ARTICLES OF INCORPORATION

<u>OF</u>

HOLLYWOOD CONSTRUCTION CONCEPTS CORP.

The undersigned, for the purpose of forming a corporation pursuant to Chapter 607, Florida

Statutes, does hereby adopt the following Articles Of Incorporation:

EFFECTIVE DATE

ARTICLE I - CORPORATE NAME

The name of this corporation is: HOLLYWOOD CONSTRUCTION CONCEPTS CORP.

ARTICLE II - TERM OF EXISTENCE

The duration of the Corporation is perpetual, unless sooner voluntarily dissolved according to law, and the existence of the Corporation commences at the time of subscription and acknowledgment of these Articles Of Incorporation on October 1, 2003, provided that these Articles Of Incorporation are filed by the Department of State within five (5) days, exclusive of legal holidays, after such subscription and acknowledgment, and in the event these Articles Of Incorporation are not filed by the Department of State within such period, the corporate existence shall commence upon the filing of the Articles Of Incorporation by the Department of State.
