ARTICLE I NAME

The name of this corporation ("Corporation") is PALM BEACH WEDDINGS AND EVENTS, INC..

ARTICLE II DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

ARTICLE III PURPOSE
