

Third: The terms and conditions of the merger are as follows:

The merging corporation shall be merged with and into the surviving corporation, and the surviving corporation shall survive the merger, all as, and with the effect, provided by the corporation laws of the State of New York, the State of Florida and this Plan of Merger. Upon the effective time of the merger, without any action on the part of the holder thereof, (i) each share of issued and outstanding Common Stock of the merging corporation held as of record by a shareholder immediately prior thereto shall be changed and converted into one share of Common stock of the surviving corporation and (ii) each share of the issued and outstanding Common Stock of the surviving corporation shall not be converted in any manner, but each said share which is issued as of such effective time shall continue to represent one issued share of the surviving corporation.

Fourth: The manner and basis of converting the shares of each corporation into shares, obligations, or other securities of the surviving corporation or any other corporation or, in whole or in part, into cash or other property and the manner and basis of converting rights to acquire shares of each corporation into rights to acquire shares, obligations, or other securities of the surviving or any other corporation or, in whole or in part, into cash or other property are as follows:
