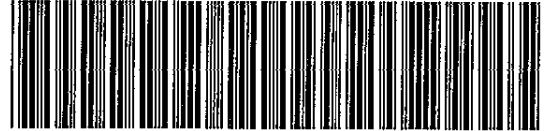

ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is "MAKE IT DIGITAL, INC.". The principal location of the corporation is 107 Cheshire Road, Daytona Beach, Florida 32118.

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

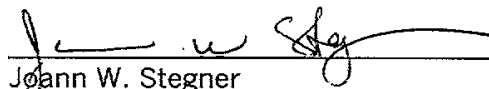

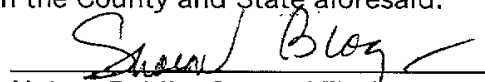

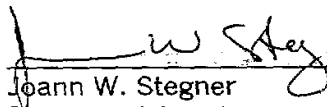
