ARTICLES OF INCORPORATION OF THOROUGHBRED MOTOR VEHICLES, INC.

The undersigned Incorporator hereby files these Articles of Incorporation and AHASSEE FLORIDA Corporation under the laws of the State of Florida.

Article 1. Name and Principal Office

The name of this Corporation shall be **THOROUGHBRED MOTOR VEHICLES, INC.** The principal place of business address of this Corporation shall be 3480 Wrightsboro Road, Augusta, Georgia 30909-2512; and the mailing address of this Corporation shall be Post Office Box 15398, Augusta, Georgia 30919-1398.

Article 2. Nature of Business

The Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.
