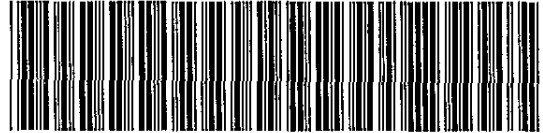


**ARTICLES XI – PRE- EMPTIVE RIGHTS**


