

On April 30, 2004, I, Irene J. Stokoe, P.A. filed my 2004 For Profit Corporation Annual Report. I then received a letter dated May 12, 2004 stating a correction needed to be made pertaining to my Federal Employer Identification Number. I made the correction and my husband presented the envelope containing the annual report to a US postal worker working the postal counter June 8, 2004. The postal worker postmarked the envelope and I had a reasonable expectation your department would soon be receiving the report within the allotted 30 days allowed for response. I have included a copy of that envelope for your inspection.

While I was in the hospital recovering from by-pass surgery, the above referenced letter/report was returned back to me in error by the post office. My daughter, Suzanne E. Stokoe, went to the post office to find out why the envelope/report had been returned. The envelope was marked for additional postage, but had been accepted at counter and later returned in error by the U.S. Post Office. The post office has apologized and stated there was no reason the letter/ report should have been returned for postage, since adequate postage was on the original envelope to begin with.

I respectfully request the \$400.00 late fee be waived because had the post office not made the error your department would have received the corrected report within the allotted 30 days. If your department feels they cannot waive this fee, please send a letter stating so and I will then file damages against the US Postal Services. I look forward to your prompt response to this matter.
