ARTICLE I. CORPORATE NAME.

The name of this corporation is: VISI CONSTRUCTION CORP.

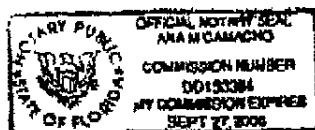

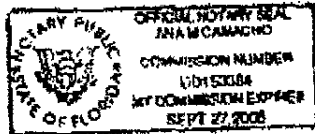
