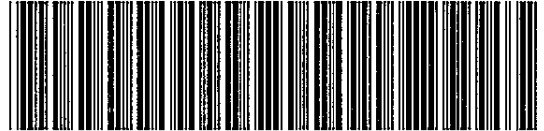

ARTICLES OF INCORPORATION

OF

The name of this corporation is A & B Management, Inc.
