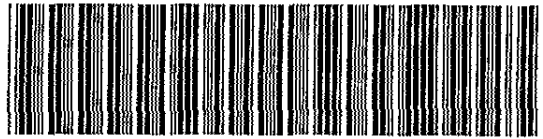

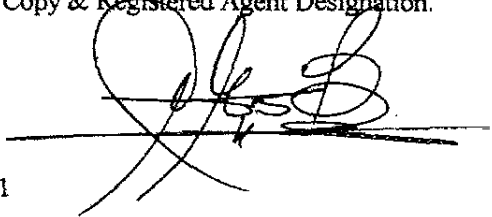

**ARTICLES OF INCORPORATION
OF

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I.

The name of the corporation shall be: CREATING CUSTOM DESIGNS, INC.

ARTICLE II.

The principle place of business and mailing address of this corporation shall be:
12117 N.W. 15th Court, Coral Springs, FL 33071

ARTICLE III.

The number of shares of stock that this corporation is authorized to have outstanding at any one time is: 100,000 shares of common stock at \$10.00 (ten dollars) per share.

ARTICLE IV.

The name and address of the initial registered agent is: Daniel Gonzalez,

ARTICLE V.

The names and street addresses of the incorporators to these Articles of Incorporation are:

ARTICLE VI.

This corporation shall have perpetual existence.

ARTICLE VII.

The purpose for which this corporation is organized, and the nature of the business to be carried on by it are stated and declared to be as follows:

To enter into any business lawful under the laws of the State of Florida, either for its own account, or for the account of others, as agents; and to the extent not to be prohibited thereby, to enter upon and engage in any kind of business of any nature whatsoever in any other state of the United States of America, to lease, buy and otherwise acquire real

estate, and to lease, sell, and/or dispose of same; to execute mortgages; to mortgage or otherwise pledge or give as security all property of every nature and kind whatsoever as security for obligation of the Corporation or for others. The general nature of the business to be transacted should include, but not be limited to the design, manufacturing, and sale of goods, e-commerce, home improvement services, and contracting.

ARTICLE VIII.

This corporation shall have five directors initially. The number of directors may be either increased or diminished from time to time by the bylaws. The names and addresses of the initial directors for this corporation are:

ARTICLE IX.

The power to adopt, alter, amend or repeal bylaws shall be vested in the directors and the shareholders.

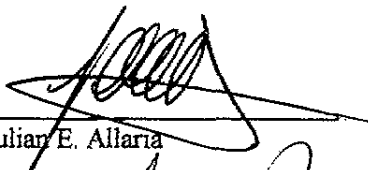
ARTICLE X.

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorated share (as nearly may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE XI.

Right of First Refusal. If a shareholder shall desire to sell his or her interest in the corporation, he or she shall be at liberty to do so, and in such case shall first offer such interest to the other shareholders at a price to be named by the selling party; and if the other shareholders shall not, within thirty (30) days thereafter, accept such offer, then the selling party shall for a period of three (3) months thereafter be at liberty to sell his or her share and interest to any other person or persons at the same or a higher price, but shall not sell it to any other person at a lesser price unless and until it shall have been offered to the other shareholders at such lesser price, and that such last mentioned offer shall not

have been accepted within thirty (30) days thereafter; provided however, that if the selling party does not sell such share and interest in the Corporation within such three (3) month period, he or she must again comply with the provision of this paragraph in respect of any subsequent sale.
