

**ARTICLES OF INCORPORATION
OF
GEORGIA GENERAL CONTRACTING, INC.**

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**Article I
Name of Corporation**

The name of the corporation (the "Corporation") is **Georgia General Contracting, Inc.**

**Article II
Principal Office**

The principal place of business is 7724 Navarre Parkway, Apt. 613, Navarre, FL 32566. The mailing address of the Corporation is 4001 Mt. Vernon Drive, Woodstock, GA 30189.

**Article III
Authorized Shares**

The maximum number of shares the Corporation is authorized to issue is 1,000, all of which shall be Common Shares, with a par value of \$.01 per share.
