ARTICLES OF INCORPORATION

ARTICLES OF INCORPORATION OF

Ruspat, Inc.

For the purpose of forming a corporation under CH.604 of the Florida General Corporation Act, it is respectfully requested at the Secretary of State the approval of such incorporation und the following Articles.

ARTICLE I

The name of this corporation shall be <u>Ruspat</u>. Inc. and its principal place of business shall be in 16259 SW 49th Courty Miramar, FL 33027 with the right to move said principal place of business and establish other places of business within or without the State of Florida as the Board of Directors may from the time deem proper.
