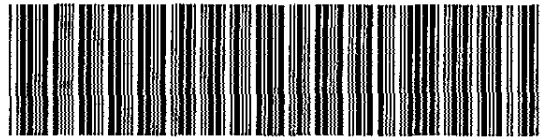


ARTICLE VIII. LIABILITY OF STOCKHOLDERS
