# ARTICLE I - NAME

The name of this corporation is Los Darias, Inc., with its principal office at 9754 Coral Way, Miami, Florida, 33165

# ARTICLE II -DURATION

This corporation shall have perpetual existence, unless dissolved in accordance with the laws of the State of Florida.
