The undersigned incorporato \overline{r} , for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be MOMAZITA SEAFOOD, INC.

ARTICLE II PRINCIPAL OFFICE
