ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of United Rx, Inc. (the "Company"), under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME AND ADDRESS

The name of the Company is: United Rx, Inc. The street address and mailing address of the initial principal office is 11250 Old St. Augustine Road, #15-241, Jacksonville, Florida 32257.

ARTICLE II. DURATION OF EXISTENCE

The Company will exist perpetually.

ARTICLE III. GENERAL PURPOSES

The general purposes for which the Company has been organized are to engage in any activity or business permitted under the laws of the United States and of the State of Florida and to carry out said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

ARTICLE IV. CAPITAL STOCK

The total number of shares of all classes of stock which the Company shall have authority to issue is 200 shares of common stock having a par value of \$0.01 per share (the "Common Stock").

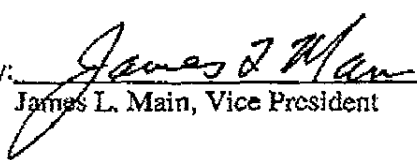
