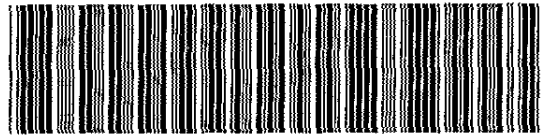

**ARTICLES OF INCORPORATION
OF

The undersigned Incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

**ARTICLE I
NAME**

The name of this corporation shall be: **FLORIDA SOUTHWEST MARKETING, INC.**

**ARTICLE II
PURPOSE**

The corporation is organized for the purpose of exercising any and all powers which a corporation or a natural person may exercise according to law.

**ARTICLE III
CAPITAL/SHARES OF STOCK**

The maximum number of shares which this corporation shall be authorized to issue and have outstanding at one time shall be limited to one million shares of voting common stock, having a par value of One Cent (\$0.01).

**ARTICLE IV
DURATION**

The corporation shall have perpetual existence, unless sooner dissolved according to law.

**ARTICLE V
REGISTERED OFFICE AND AGENT**

The principal office of this corporation shall be located at 1358 Thomaswood Drive, Tallahassee, Florida 32308, or at such other place as may from time to time be fixed by the Board of Directors. The initial registered agent of the corporation at such address is **D. Andrew Byrne**.

**ARTICLE VI
DIRECTORS AND OFFICERS**

The number of directors of this corporation shall not be less than one (1), to be fixed from time to time by resolution of the stockholders of this corporation at their annual meeting prior to the election of directors. All shall be of full age. They shall be elected by a majority of the stock present and participating in the annual meeting of the corporation to be held as prescribed by the By-Laws

and shall hold office after their election for the ensuing year and until their successors are duly elected and qualified. The officers shall be appointed by the Board in accordance with the By-Laws.

ARTICLE VII INITIAL DIRECTORS

The names and addresses of the first Board of Directors, who shall hold office until their successors are elected or appointed and have qualified, are as follows: Jonathan W. Been, Post Office Box 420367, Atlanta, Georgia 30342.

ARTICLE VIII INDEMNIFICATION OF OFFICERS

This corporation shall have power to indemnify its officers, employees or agents to the full extent provided by Section 607.014, Florida Statutes, or other provisions of Florida law as they may exist from time to time.

ARTICLE X CUMULATIVE VOTING AND PREEMPTIVE RIGHTS

At each election for directors, stockholders shall not be entitled to cumulate their votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of shares, or by distributing those votes on the same principal among any number of candidates.


