ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: SOUTHERN MAGNOLIA ENTERPRISES, INC. The principal office of the Corporation is 5135 Haywood Ruffin Road, St. Cloud, Florida 34771. The mailing address of the Corporation is 200 E. Robinson Street, Suite 500, Orlando, Florida 32801.


