## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: SPARTACUS INVESTMENT GROUP, INC., 4565 S. Atlantic Avenue, Suite 5510, Ponce Inlet, Florida 32127.
