


ARTICLE XI



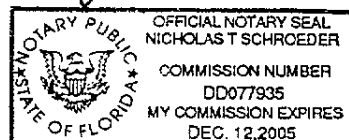
