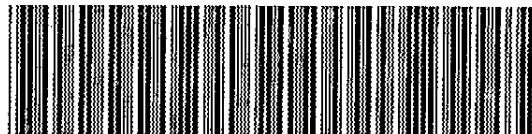

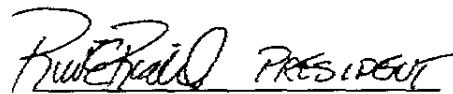
ARTICLE VII--AMENDMENT

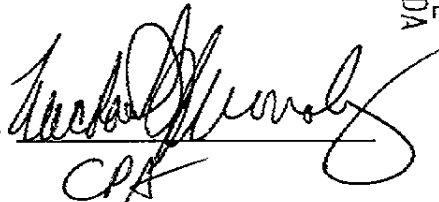

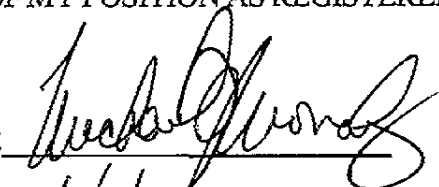
