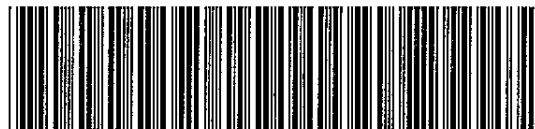

The undersigned incorporator, for the purpose of forming a professional association under Professional Services Corporation Act, hereby adopts the following Articles of Incorporation:

Article I
Name and Duration

The name of this professional association is BRYAN SHORSTEIN, P.A. The duration of the professional association is perpetual. The effective date upon which this professional association shall come into existence shall be the date these Articles of Incorporation are filed by the Department of State.

Article II
Principal Office

The address of the principal office and mailing address of the professional association in the State of Florida is 19 Old Mission Avenue, Saint Augustine, Florida 32084.

Article III
Corporate Purposes, Powers and Rights

The general purpose for which this professional association is organized shall be to render professional legal services to the general public, and to do all things in connection therewith that are customarily done by attorneys at law under the laws of the State of Florida. In furtherance of its corporate purposes, the professional association shall have all of the general and specific powers and rights granted to and conferred upon a corporation by the Professional Service Corporation Act.

Article IV
Capital Stock

The maximum number of shares of stock which this professional association is authorized to have outstanding at any one time is one thousand (1,000) shares having no par value.

Article V
Registered Office and Agent

The street address of the registered office of this professional association is 19 Old Mission Avenue, Saint Augustine, Florida 32084, and the name of the registered agent of this professional association at such address is Bryan L. Shorstein.

**Article VI
Directors**

This professional association shall have one (1) director initially. The number of directors may be increased or diminished from time to time in accordance with the Bylaws, but shall never be less than one (1). **Article VII
Bylaws**

Amendment**

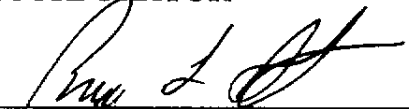

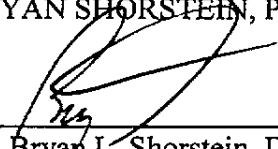

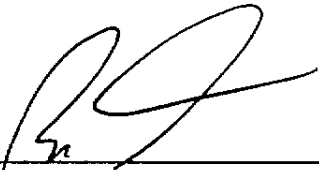
