ARTICLES OF INCORPORATION

OF

SYSTEMLINK BROADBAND CORP.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE - NAME AND MAILING ADDRESS

The name of the Corporation is SystemLink Broadband Corp. NThe mailing address for the corporation is 4730 110th Ave. N., Clearwater Florida 33762.

ARTICLE TWO - TERM OF EXISTENCE

The corporation shall have perpetual existence.

ARTICLE THREE - PURPOSE

The purposes for which the Corporation is organized are:
