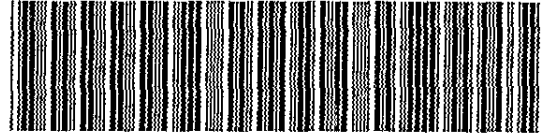

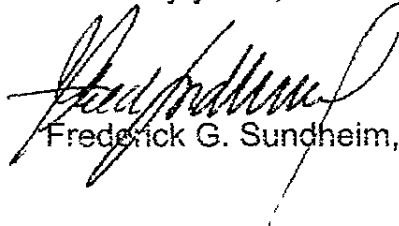

ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation shall be EAST COAST TINTING AND DESIGN, INC.

ARTICLE II. TERM OF EXISTENCE

This corporation is to exist perpetually.
