**ARTICLES OF INCORPORATION**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I  
NAME**

The name of the corporation shall Caride Investment, Inc. For convenience, the Corporation shall be referred to in this instrument as the "Corporation".

**ARTICLE II  
PLACE OF BUSINESS**

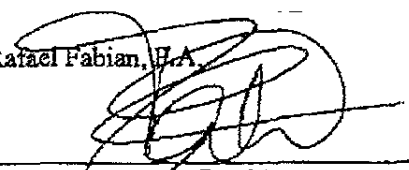
