
ARTICLE XII


ARTICLE XIII



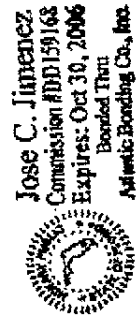
