**ARTICLES OF DISSOLUTION
FOR
ALLWAC MANAGEMENT COMPANY, INC.**

Pursuant to Section 607.1402 and Section 607.1403 of the Florida Statutes, this Florida profit corporation submits the following Articles of Dissolution:

Article I

The name of the corporation as currently filed with the Florida Department of State is **ALLWAC MANAGEMENT COMPANY, INC.** (the "Company").

Article II

The document number of the Company with the Florida Department of State is P03000113430.

Article III

The original file date of the Articles of Incorporation for the Company was October 13, 2003 and the original effective date of the Articles of Incorporation of the Company was October 10, 2003.

Article IV

The Company authorized one class of common stock consisting of two types, Type A and Type B. Twenty Thousand (20,000) shares of the Company's Type A common stock were authorized with a Par Value of \$0.01 per share. Two Hundred Thousand (200,000) shares of the Company's Type B common stock were authorized with a Par Value of \$0.01 per share.

Article V

There are no outstanding debts for the Company and no debt of the Company remains unpaid.

Article VI

Upon written consent and resolution duly made on October 25, 2013, the shareholders, with a number of votes sufficient for approval, and directors unanimously authorized the dissolution of the Company.
